

is intending to apply to the Welsh Ministers for planning permission in respect of Development of National Significance which is (c) :	<p>Description of the proposed development</p> <p>The Proposed Development is a wind farm consisting of a maximum of seven wind turbines, each with a 3-bladed rotor with a diameter of up to 136m, a hub height of up to 97.5m and maximum height to blade tip of 155m.</p> <p>The application also comprises associated infrastructure including a new access and junction off the main highway, internal wind farm tracks off the main access corridor, crane pads at each turbine location, turbine foundations, laydown and storage areas, underground power cables linking the turbines and the on-site substation, temporary construction compounds, and grid connection infrastructure, including an on-site substation and control building together with construction enabling works.</p>


